

**TERMS AND CONDITIONS IN RESPECT OF
K DOLLAR PROGRAM DOUBLE REWARDS
(From 21 April 2022 to 31 May 2022)**

1. Applicable Activity

Example:

If a Member makes an Eligible Spending at: (i) Chow Tai Fook in K11 MUSEA; (ii) another participating merchant in K11 MUSEA; and (iii) a participating merchant in K11 Art Mall, the Member's Eligible Spendings will be classified as under two different Participating Partners: Chow Tai Fook and K11. Accordingly, the Member will be able to collect 2 e-Badges (i.e. an extra bonus of 50 K Dollars).

For the first 1,000 Members who have collected 2 or more e-Badges, an additional 50 K Dollars will be rewarded from FTLife upon the successful completion of FTLife's customer survey ("**FTLife Survey**"). 3. K Dollar Rewards Validity Period

4. Special Terms and Conditions applicable to the Activity

4.1. Terms Used

- 4.1.1. "**Eligible Receipt**" means an original machine-printed receipt issued by a participating merchant of the Participating Partner(s) / the Participating Partner on the date of redemption for an Eligible Spending. KDP and the respective Participating Partner(s) do not accept any photocopies or handwritten receipts and reserve the right not to accept any receipts that KDP and the respective Participating Partner(s) suspect to be invalid, forged or issued not for genuine transactions or on other grounds without any need for explanation.
- 4.1.2. "**Eligible Spending**" means a consumer transaction paid by a Member at a participating merchant of the Participating Partner / the Participating Partner. For details of an "Eligible Spending" of each Participating Partner, please refer to the terms and conditions of the earning proposition listed on each applicable Partner Page of KDP at <https://hk.krewards.com/partner/>, and all relevant terms and conditions related to this Activity.
- 4.1.3. Other terms not defined in these Terms and Conditions shall have the same meanings as defined in the KDP Terms and Conditions.

4.2. Registration of Eligible Spending

- 4.2.1. For the purpose of calculating the Eligible Spending, all Eligible Spending is required to be successfully registered in accordance with the KDP Terms and Conditions and the applicable terms and conditions of the respective Participating Partner(s).
- 4.2.2. A Member shall forthwith inform KDP and the respective Participating Partner(s) of any transaction where Benefits (as defined in the KDP Terms and Conditions) / K Dollars have been earned/obtained/redeemed but such transaction is subsequently cancelled, refunded or reversed for whatever reasons. Member shall present his or her valid KDP e-Membership Card for inspection at the time of spending and/or redemption. Where applicable, Members may also be required to present his or her membership of the relevant Participating Partner.

4.6. No Exchange

The Rewards cannot be exchanged for cash, other gifts or privileges.

4.7. No Liability

KDP and respective Participating Partner(s) do not warrant that the products and services offered by the individual merchants or redeemed by the participants in the Activity are of any merchantable quality or fit for any purpose, and disclaim all liability in relation to such products and services. Any participants in the Activity shall waive all his/her rights and interests, if any, of any natures to pursue against KDP and the respective Participating Partner(s).

4.8. Termination of the Activity

KDP has the right to suspend, terminate or cancel the Activity at any time without any prior notice.

5. General Terms and Conditions applicable to the Activity

5.1. Amendment

KDP has the right to amend any these Terms and Conditions at any time without any prior notice.

5.2. Interpretation

KDP has the right to interpret these Terms and Conditions. In case of disputes, the decision of KDP and the respective Participating Partner(s) shall be final and binding on all parties concerned.

5.3. English Version Prevails

The Chinese version of these Terms and Conditions are for reference only. In case of discrepancies between the provisions of the English version and the Chinese version, the English version will prevail.

5.4. Governing Laws

These Terms and Conditions shall be governed by the laws of Hong Kong Special Administrative Region.
