

**TERMS AND CONDITIONS IN RESPECT OF
HSBC REWARDCASH X K DOLLAR CONVERSION PROMOTION**

1. Applicable Activity

By participating in the activity organised by K Dollar Program (“KDP”) as set out in Clause 2 below (the “Activity”), a participant is deemed to have read, understood and agreed to the terms and conditions applicable to the Activity (“Terms and Conditions”).
